## Protective Orders

If you are the victim of violence you may petition the **First District Court** for a protective order. The purpose for a protective order is :

- Stop the Violence.
- Prohibit Communication.
- Order the Perpetrator to stay away from residence or anywhere frequented by victim.
- No Weapons in the possession of the Perpetrator.
- To gain possession of automobile and personal effects.
- Temporary custody of children.
- Other relief necessary for safety.

Once the Ex-Parte (temporary) Protective Order is granted, it is served immediately. A court date is set for a Protective Order hearing. Violation of a Protective Order is a Class A Misdemeanor, and any subsequent violations may be enhanced to felonies.

Law Enforcement takes an aggressive role when dealing with Protective Order complaints.
